IMI COMPLIANCE 101

Alrighty, folks, let's get down to brass tacks and wrap our heads around this whole IMI compliance thing. Picture this: you've got your trusty mail system chugging along, doing its thing day in, day out. But now, there's a new sheriff in town - the Intelligent Mail Indicia (IMI) standard.

SO, WHAT EXACTLY IS IMI COMPLIANCE?

Think of it as the rulebook for modernizing your mailing game. IMI compliance means following the guidelines set forth by the United States Postal Service (USPS) to adopt the IMI standard on your mailpieces. It's

like giving your old-school postage stamp a digital makeover, complete with all the bells and whistles of the 21st century.

Why does it matter? Well, imagine trying to navigate a bustling city without a GPS - it's chaos, right? IMI compliance is like giving your mail system a GPS, guiding each piece with pinpoint accuracy from sender to recipient. THE TECHNICAL STUFF:

Intelligent Mail Indicia (IMI): IMI stands for Intelligent Mail Indicia, and it's simply the barcode technology stamped onto mail to sort and track it through the post office. This 65-bar Postal Service barcode is printed on envelopes, typically near the recipient's address.

The **Intelligent Mail barcode (or IMb)** is unique in its ability to encode up to 31 digits of mailpiece data into 65 vertical bars using a 4-state symbology. The 65 bars encode a string of 31 digits, which are divided into two parts: a 20-digit tracking code and an 11-digit routing code (when required). This coding allows for precise tracking and sorting, enhancing the accuracy and efficiency of mail processing.

The USPS is switching away from its outdated **Information-Based Indicia (IBI)** technology to this modernized IMI standard. Key differences in IMI technology include more transparent transaction data, automation of back-office operations, and enhanced security features such as state-of-the-art data encryption.

IMI technology provides users with **Federal Information Processing Standards (FIPS)** 140-2 security, recognized both within and outside the United States as the best security standard for protecting sensitive mailpiece data and safeguarding against tampering and fraud.

IMI adheres to the guidelines set by the Federal Information Processing Standards (FIPS), which are developed and maintained by the **National Institute of Standards and Technology (NIST)** to set the standards for data encryption and protection of federal IT systems. With these native security standards, you know your data has ironclad encryption and is transmitted securely, going to or from the postage meter.

3 MORE CONVENIENCE

With IMI, automatic updates are the name of the game. The USPS requires systems with IMI to connect to the manufacturer's servers every 72 hours, ensuring you're always up to date with the latest rate changes and modifications. No more scrambling to manually update your meter - IMI does the heavy lifting for you.

GREATER CONNECTIVITY

Forget about dedicated phone lines - IMI-enabled systems use dedicated LAN connections for a constant, reliable connection. This means faster updates, quicker postage refills, and seamless integration into your existing systems.

IMI COMPLIANCE DEADLINES YOU NEED TO KNOW

The USPS isn't messing around when it comes to implementing changes to ensure the adoption of Intelligent Mail Indicia standards across all mailing systems. So, here's what you need to know to stay ahead of the game.

DECERTIFICATION DEADLINE: JUNE 30TH, 2024

Circle this date on your calendar - June 30th, 2024. On this day, all postage meters and mailing systems that do not meet the USPS IMI compliance standards will be decertified faster than you can say "snail mail." You won't be able to add postage funds or download software updates, and your mailing operation will be considered non-compliant.



If your current postage meter is an Information Based Indicia (IBI) device, it's past time to start thinking about upgrading to one that is IMI-compliant. And don't procrastinate - once June 30th rolls around, the clock is ticking.



GRACE PERIOD UNTIL: DECEMBER 31ST, 2024

The USPS is offering a grace period until December 31st, 2024. During this time, you can still use your existing postage meter without fear of immediate repercussions. However, come January 1st, 2025, your machine will officially be declared inactive if it doesn't meet the new requirements.

So, what does this mean for you? Well, it's time to start planning your upgrade. Whether you're purchasing or leasing a new IMI-compliant machine or making the switch to a software solution, make sure you have a plan in place to avoid any disruptions to your mailing operations.

FUND USAGE: POST-DECERTIFICATION

Even though your decertified machine can still be used until the end of 2024, you won't be able to add any additional funds after June 30th, 2024. That means that once the clock strikes midnight, it's game over for fund usage on non-compliant machines.



And mark your calendars for June 30th, 2025, too - after this date, any postage indicia printed by decertified mailing systems will be useless. So, be sure to submit your refund requests for all unused postage before this deadline to avoid getting left in the lurch.

Once December 31st, 2024 rolls around, outdated postage and mailing machines will truly become inactive if they are not IMI-compliant. So, it's best to make the switch sooner rather than later to avoid any disruptions to your mailing operations.
